ROLL CALL

PARTICIPATION AGREEMENT

In 2021 the GA set up Points of Order and a good faith Participation Agreement that was created and deliberated in our Outreach and Communication Committee (w/GA participation), voted on in committee, voted on in the GA and followed up by approval from Anna Von Reitz and the Federation. All members considered to be in good standing, agree and autograph their commitment to the Participation Agreement– that without this commitment of good faith, we should not be expected to have confidence in your intentions. The Participation Agreement is required to be considered in good standing with the Assembly. BEVINS DECLARATION

This is a public meeting. Anyone in this meeting claiming any form of US Citizenship or employment with any Federal Agency is now -- for the next segment of this General Assembly meeting, invited to either declare your presence and business here or, we ask you to leave the Assembly at this time.

I will repeat, If you are a US citizen or an undeclared Federal Agent, please raise your hands or vacate our meeting.

For the 3rd and final time, this is Notice that if you don't respond appropriately to this Bevin's Declaration, immediately, you are made fully liable for your lack of disclosure and any "so-called" evidence that you collect is tainted and inadmissible. No one can attend any of our meetings in secret, or in private, without answering roll call or without announcing or declaring their presence.

HOW TO GET YOURSELF HEARD

All committees are formed in a General Assembly meeting, where all qualified participants (fully published & NMO complete, domiciled on Tennessee one year and one day, autographed & sealed Participation Agreement) have an equal opportunity to join. Committee sizes will generally be around 5 (not a fixed number) and can grow w/the active number of qualified participants in regular attendance. New members may attend these meetings upon invitation, just not nominate/vote in committee matters. This Assembly is the only recognized Tennessee Assembly with provenance. We are a committee-based organization. It is always open to allow qualified participants to join committees - we require that you have your paperwork done and complete the NMO classes and Knowledge Review first and be willing to covenant with us by signing and sealing your common courtesy Participation Agreement.

There are recommended and necessary committees under each of the 4 Pillars. Each Committee's first order of business is to elect a Chair, Co-Chair and Secretary. If a mission statement has not been created, then that committee should work on summarizing that committee's goals and purpose. That committee should determine how often they should meet and times. The Chair is a facilitator/moderator and not a CEO. We have no power positions. A committee can vote on topics and when it concerns a vote from the GA, the chair or co-chair will report in the GA and ask for a vote in advance as to include it in the GA Agenda. We ask that all committees are formed in the General Assembly and ask for qualified ASN's/ASC's to join. Anna has written that the only Assembly that is similar to the GA as far as how it is facilitated is the International Business Assembly comprised only of ASC's. Committees can be formed in the IBA as only ASC's can seat those committees. Those committees will report in the GA.

Right now we don't have quorums or proxies, whoever shows up (and is qualified) will determine the quorum. Some items will require unanimous vote, and a majority vote is no less than 70% in our Republican form of govt. Please read Anna's article explaining the difference b/t Republic and Republican form of govt as it should be helpful to our naming conventions vs 'theirs'
